3(d) It has been unanimously resolved by the Panchayat body to write a letter to the Manager of Rail Vikas, KFC Building 1st Floor, Margao-Goa regarding to request to construct a drain from Indona, cotta to Tolleaband behind Rosary Chapel, width approximately 1.5 mtr and depth 1.00 mtr to flow the rain water which was blocked during last rainy season and field was destroyed by the rain water, to avoid this you are hereby requested to construct the said existing drain near retaining wall recently constructed as early as possible and the said drain may be constructed in your property.
